Notes	I. Graduation requires at least 128 credit hours, of which at least 61 should be from required courses in the department of the student's major, at least 21 from core elective courses, 2 from labor service, 2 from volunteer service and at least 19 from general education courses. 16 credits are accepted from any subjects from all departments. II. "General Education Courses" must be conducted in accordance with the regulations of the General Education Center and reach the required credits standards set by the school. III. The "Study Passport" course is a compulsory course with zero credits, and you can only graduate after passing it. (According to the implementation rule of the "Study Passport" course of Kainan University) IV. The English threshold for graduation of the students of this school is handled in accordance with the "Key Points for the Implementation of the Graduation Threshold for Students with English Proficiency" V. "Secondary five academic system students" should increase their graduation credits (at least 12 credits). VI. All general education courses must be regulated by the policies of the Center of General Education. Students must complete the required credits set by the university. VII. Those who have not passed elementary accounting are not allowed to study intermediate accounting. VIII. These course regulations were passed at the Curriculum Committee Meeting on May 19th, 2020 and approved for future references by the Academic Affairs Meeting on May 19th, 2020.
